#### Introduction

- GoU has several laws & policies aimed at empowering women to effectively participate in the political, economic & social spheres of life.
- Nonetheless, gender inequality remains a huge development challenge for Uganda.
  - E.g. female unemployment rate
    (13.1%) is more than double that of their male counterparts (5.8%).

- To promote peace, a country's growth must be inclusive and sustainable (Organisation for Security and Cooperation in Europe [OSCE]).
- Adequate public allocations for gender and equity interventions is a sure way of ensuring inclusivity.
- This presentation examines domestic and donor spending on interventions intended to promote GEWE in Uganda.



# In absolute amounts, budget allocations to GEWE interventions have increased remarkably – by >34% between FY 2017/18 & 2018/19

- National budget
- Budget committed to Gender & equity (Real amount in Billion UGX)



National budget allocation to GEWE interventions increased by about three percentage points from 26.0% in FY 2017/18 to 28.9% in FY 2018/19.




### The increased budget allocations to gender-focused interventions are not uniform across sectors.

Share of sectoral allocations to GEWE interventions partly reflects the weight attached to GEWE; Some sectors surpass the national average of 28.9%






## There are minimal variations between budget allocations & released funds, suggesting that GEWE interventions are minimally affected by budgets and reallocations.

## Since the adoption of SDGs in 2015, Uganda has increasingly received aid for projects targeting GEWE; however, effective donor commitment remains uncertain



### **Emerging Issues for policy consideration**

1

 GoU needs to continue relying less on donor funding for GEWE activities given the observed inconsistencies in commitments & disbursements. 2

 MoFPED together with URA should expedite strategies for increasing domestic resource mobilisation such that sectoral & **GEWE** allocations can sustainably be increased annually.

3

 GoU should establish a standard proportion of sector allocations that should be earmarked for gender equality and women's empowerment.
